DISCUSSION WAS HELD ON THE LEAK ADJUSTMENT REPORT FOR JUNE 2025. THE BOARD APPROVED THE CUSTOMER LEAK ADJUSTMENTS IN THE AMOUNT OF \$3,306.83 AND CATASTROPHIC LEAKS IN THE AMOUNT OF \$707.12, ON A MOTION BY MS. BARGER, SECOND BY MR. COOK. THE MOTION PASSED UNANIMOUSLY.

MR. CARDWELL UPDATED THE BOARD ON THE PROGRESS OF THE FOLLOWING CAPITAL IMPROVEMENT PROJECTS.

THE BOARD APPROVED THE PAY REQUESTS, UPON RECOMMENDATION BY THE CONSULTING ENGINEER, ON A MOTION BY MR. COOK, SECOND BY MS. BARGER. THE MOTION PASSED UNANIMOUSLY.

DISCUSSION WAS HELD ON THE ESTABLISHMENT OF A CONTRACTOR RETAINAGE ACCOUNT AT PINNACLE BANK FOR THE MELTON HILL WATER TREATMENT PLANT SEDIMENTATION IMPROVEMENTS PROJECT. THE BOARD APPROVED THE NEW ACCOUNT ON A MOTION BY MS. BARGER, SECOND BY MR. COOK. THE MOTION PASSED UNANIMOUSLY.

DISCUSSION WAS HELD ON THE RECENT BID OPENING FOR THE NORRIS WATER TREATMENT PLANT DISINFECTION IMPROVEMENTS. THE PROJECT WILL BE FUNDED BY AN ARP (AMERICAN RESCUE PLAN) GRANT AND IS CONTINGENT UPON FINAL APPROVAL FROM UNION COUNTY. AS RECOMMENDED BY THE CONSULTING ENGINEER, FOX, PE, THE PROJECT WAS AWARDED TO THE LOW BIDDER: DESIGN AND CONSTRUCTION SERVICES, INC, FOR THE AMOUNT OF \$226,800.00, ON A MOTION BY MR. COOK, SECOND BY MS. BARGER. THE MOTION PASSED UNANIMOUSLY.

SUMMER PRICE PRESENTED A DEBIT SCHEDULE AND CT-0253 REGARDING THE RECENTLY CLOSED UTILITIES IMPROVEMENT REVENUE BOND, RD WATER SERIES 2025C.

DISCUSSION WAS HELD ON THE COMMISSIONER NOMINATION REVIEW AND RECOMMENDATION FOR MS. BARGER'S TERM OF OFFICE, WHICH EXPIRES ON SEPTEMBER 14, 2025. BALLOTS WERE PROVIDED FOR RANKING THE APPLICATIONS SUBMITTED. AFTER REVIEW OF THE INDIVIDUAL RANKINGS FROM MR. JULIAN AND MR. COOK, THE BOARD VOTED TO SUBMIT THE FOLLOWING INDIVIDUALS, IN ORDER OF PREFERENCE, TO THE COUNTY MAYOR FOR CONSIDERATION AS COMMISSIONER ON A MOTION BY MR. COOK, SECOND BY MR. JULIAN. THE MOTION PASSED UNANIMOUSLY. (MS. BARGER ABSTAINED FROM THE VOTE.)
