## **SUCCESS IN ACTION The Projects Behind Our Progress**

We are happy to announce that HPUD has been released from the 2014 Consent Order (CO) issued by TDEC. The CO was a result of an aging system that was in much need of repair. Pictured to the top right is the old 36 inch sewer interceptor that was plagued with inflow and infiltration issues due to old, deteriorating pipes. The picture below is of the new 48-inch interceptor.

Since the new interceptor came online, HPUD has seen the lowest sanitary sewer overflows on record. The peak and instantaneous flows are lower and the recovery time is quicker after rain events.



#### <u>Improvements Completed During the Consent Order</u>

- 157,272 Linear Feet of Sewer Pipe
- 1,046 Manholes
- 11 Lift Stations

As a result of these efforts, Hallsdale-Powell Utility District was awarded the 2024 Outstanding Abatement Project Award by the Clean Water Professionals of Kentucky & Tennessee.
